Meeting Summary: This was the very first meeting of the 2014-2015 CSF Committee. The committee determined Letters of Intent (LOI) will be due Tuesday, November 18th and full proposals will be submitted by Janurary 20th, 2015. Discussion surrounding Chair and Vice Chair appointments resulted in an agreement to do an anonymous poll online by the end of next Friday (11/7) after candidates have submitted their paragraphs of qualifications and motivations by noon of Tuesday, November 4th. The CSF Coordinator briefly went over the two CSF projects that required committee attention over the summer. A discussion around the CSF mission statement brought up the question about its wording and clarity. More discussion to come...

Introductions

Chair & Vice Chair elections:

- Chair: Sets the meeting agenda and leads the meeting, takes input from other committee and staff members, tends to take a heavier role in reallocation of funds from SAF, figurehead for fund for public affairs.
- Vice Chair: Takes minutes for the minutes and sends them out, takes care of Chair roles if Chair cannot make a meeting
- Might hold off until next week because not all committee members are here
- Appreciated it we waited for all, Erin liked being up to date last year -- strange as a new member of CSF and everyone hits the ground running, valuable to know what people are running for and why
- Natalie might not make it next week
- Can do it through anonymous Google poll since everyone can't make it all the meetings all the time
- We must also consider how we want to make the ESC appointment
- We can do all three of these positions at once, or doing Chair and Vice Chair first so that we have something to fall back on (make by December 9th)
- Tuesday, November 4th at noon: Committee members interested in running for Chair or Vice Chair will submit a paragraph explaining their qualifications and motivations for the positions. These paragraphs will get sent out to the rest of the committee by 4pm that day.
- Committee members will then have until the end of the day on Friday, November 7th to vote via a Google poll for Chair and Vice Chair appointments

Summer Updates

- First time that we've had an interim committee! Helped make decisions around projects that needed some oversight and guidance
- Green Labs: pilot project for fixing lights and aerators, since then there has been a green labs division but not within the specific scope that we have funded, they are looking for contingency funding
- Lights On: In the atmospheric sciences building (Johnson) replace automatic light sensors, project got up to about 50% but then major changes to the building happened and project would have gotten in the way of emergency lighting and project lead left. The money is still there and there are some

- students who are interested in being a part of this, facilities and services have been taking this one for now "scope transfer"
- We have plenty of time to go over these projects

CSF Committee Job Descriptions

- Came out of work done with summer, we didn't have job descriptions for committee members
- Are these reflected in the bylaws? Yes, for the most part, except for hour estimates for certain tasks
- Emphasizing more accountability for each committee member for student fees, more specifically in the required duties or blurb at the top most of our funds comes from the students activities fee
- GG will come up language and we will vote later
- Add qualifications about being interested in what we do → You must be interested in campus sustainability ©
- Phrase at the beginning feels like a run-on sentence, the mission is wordy? More clarity!
- We should be consistent with what we are doing with our mission statement. We would come up with some new language, discuss, and then vote.
- Difference between something that is put on a poster vs. a more formal thing. Changes should be made consistently.
